

NSS SAR NIF CONTRIBUTION!!!

The BC Tracking Association is very grateful to the National Search and Rescue Secretariat (NSS) for the SAR New Initiatives Fund (NIF) Contribution Agreement we have received for 2011. The Agreement is "To establish, maintain and oversee proven and consistent human tracking training standards in the province of BC with the primary goal to have every certified ground SAR volunteer in BC trained to a minimum of Track Aware."

This agreement will enable the Association to provide certified tracking instructor training and In-House GSAR tracker training in British Columbia at considerably reduced costs to Association members.

What this means to BCTA Members is that they will be subsidized and/or may claim reimbursement for some training costs based on the agreement criteria, as outlined below. Association members wishing to attend a BCTA sponsored tracking course will have to pre-pay all the associated tuition and fees up-front when they register for the course. However, following the successful completion of the course, they can submit a reimbursement claim to the

BCTA, which may include the following:

Track Aware Novices could be offered up to 24 BCTA sponsored In-House Track Aware classes. BCTA Members will pay a tuition fee of \$50 per In-House course, which is not claimable. The normal course fee would be \$175. so this is a considerable saving! Nonmembers will be charged \$100 for a BCTA sponsored In-House course. If they complete a membership form upon registration, the tuition fee can be reduced to \$65. Association members will be entitled to claim reimbursement for transportation if they live more than 40 km one-way from the training location, up to a maximum of 500 km round trip at the rate of 52 cents/km. Car-pooling is encouraged. Only the driver may claim the mileage. Accommodation and meals are at the student's expense and are not reimbursed.

Tracker 1, 2 and Sign Cutters will be offered up to six BCTA sponsored advanced Universal Tracking Services (UTS) courses. BCTA Members will be able to claim reimbursement for the UTS tuition of \$175 (Cdn), plus transportation if they live more than 40 km one-way from the training location, up to a

maximum of 500 km round trip at the rate of 52 cents/km. Car-pooling is encouraged. Only the driver may claim the mileage. Accommodation and meals are at the student's expense and are not reimbursed.

Train the Trainers will be offered two BCTA sponsored UTS TTT courses in 2011, for up to 15 students each. BCTA Members will be able to claim reimbursement for the UTS tuition of \$175 (Cdn), plus transportation if they live more than 40 km one-way from the training location, up to a maximum of 500 km round trip at the rate of 52 cents/km. Car-pooling is encouraged. Only the driver may claim the mileage. Shared commercial accommodation can be reimbursed up to \$125 per night plus taxes for two people, or campsite fees, etc. with receipts. Meal packages during the course can also be reimbursed. In return, the BCTA will expect certified trainers to sign a letter of support, hoursin-kind, to volunteer to instruct at In-House courses.. These letters will be very useful for future grant applications.

BCTA/UTS Certified **Instructors** assigned by the Training Committee as instructors on BCTA sponsored In-House courses will be reimbursed for out-of-pocket expenses, including travel, meals and accommodation, within prescribed limits. Instructors will volunteer their time for travel and instruction, and will not be compensated for their hours. This is how the Association can offer the lowest possible tuition rates to In-House students.

Course Coordinators for groups hosting BCTA sponsored In-House courses, may be reimbursed for training manuals, hall rentals and other costs

associated with organizing and running a course. Details will be provided by the BCTA Regional Director when a sponsored course is requested.

Correspondence: The Executive has received a quote for Directors and Officers Liability insurance, similar to the insurance all BC GSAR groups carry. Details of the coverage and cost are being worked out.

Membership:

Peggy Shelley agreed to take over the task of producing membership cards. It was recommended that BCTA certificates be sent to the individual's SAR group for presentation at suitable occasions.

Policy Committee: The Board approved the Training Policy, which sets the reimbursements for BCTA Certified Instructors.

Tracker Call Out Committee: Peter Wilson and Mike Neeland volunteered to organize the Call Out system. The new BCTA membership form will ask members if they wish to have their name and contact information provided for the Tracker Call Out list. This may include Trackers who are currently not members of SAR groups. Members who are willing and available are asked to check off the response and they will be added to the Tracker Call Out list.

Tracker Advisors Another best practices review item was a recommendation to provide senior Tracker Advisors to support SAR Management where significant trackers are tasked. Again, Peter and Mike are

working on the details, but selected Sign Cutters or TK2s with SAR Manager certification could be called upon as specialist advisors to the Operations Chief or SAR Managers on a task.

Community Gaming Grant: The Association will re-apply for 2012. A volunteer is required to update and prepare the grant application. Deadline for the submission is August 2011.

BCTA Annual General Meeting will be held at the Shuswap course on Saturday 23 September. Members unable to attend in person may be able to participate via teleconference or Skype. The Summer 2011 newsletter will announce the details of the agenda, the budget for 2011 and election of Executive and Regional Director positions.
